

PATHWAYS WAS FOUNDED WITH THE MISSION TO TRANSFORM THE LIVES OF PEOPLE EXPERIENCING CHRONIC HOMELESSNESS DUE TO MENTAL HEALTH CHALLENGES AND OTHER DISABILITIES BY SUPPORTING SELF-DIRECTED RECOVERY AND COMMUNITY INTEGRATION. THROUGH THE HOUSING FIRST MODEL, WE HAVE DEVELOPED A SUCCESSFUL PATH OUT OF HOMELESSNESS, BY FIRST ENSURING SAFE AND STABLE HOUSING FOR THESE INDIVIDUALS AND THEN ADDRESSING THEIR UNDERLYING ISSUES AROUND MENTAL HEALTH, SUBSTANCE USE, MEDICAL CARE, INCOME, AND EDUCATION. THESE ARE THE SIMPLE, HUMAN GOALS OF THE PHILADELPHIA FURNITURE BANK - TURNING EMPTY HOUSES INTO WELCOMING HOMES BY PROVIDING NO-COST FURNISHINGS TO INDIVIDUALS AND FAMILIES IN NEED. OTHER USEABLE HOUSEHOLD ITEMS ARE SENT TO OUR PARTNER NONPROFITS LIKE CIRCLE THRIFT AND HABITAT FOR HUMANITY'S RESTORE, TECHNOLOGY AND OTHER RECYCLABLE ITEMS ARE RECYCLED, METAL IS SCRAPPED, AND THE AMOUNT OF ITEMS THAT END UP IN A LANDFILL ARE MINIMIZED TO THE BEST OF OUR ABILITY. REVENUE FROM GOOD HAUL IS REINVESTED IN THE PHILADELPHIA FURNITURE BANK. GOOD HAUL IS STILL IN THE EARLY STAGES, BUT IS ON TARGET TO MEET ITS GOALS FOR THE COMING YEAR.
